**WAIVER AND RELEASE OF LIABILITY**

This waiver is valid for one year from the date signed.

In consideration of Bearded Axe, LLC DBA (herein after referred to as Bearded Axe) furnishing services and/or equipment to enable me, or the minor(s) I am signing for, to participate in Mobile Axe Throwing I agree as follows:

I fully understand and acknowledge that; (a) risks and dangers exist in my use of Mobile Axe Throwing equipment and my participation in Mobile Axe Throwing activities; (b) my participation in such activities and/or use of such equipment may result in my injury or illness including but not limited to bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability; (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Bearded Axe; the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees of Bearded Axe, or by any other person

MEDICAL PERMISSION AUTHORIZATION**

I further agree that I have read, and will adhere to all Safety Rules for the Bearded Axe Facility / Trailer, and I have watched the safety briefing, either on line, or at the facility.

**I understand that violation of any of the other safety rules outlined in the Safety Briefing, is grounds for immediate suspension of playing privileges without any refund.**

I understand that as a public facility, pictures and or video may be taken by Bearded Axe staff or others, and I grant them the right to publish, and re-publish video, photographic portraits, or pictures of me in which I may be included, in whole or in part.

I understand that this facility allows no outside axes or personal weapons of any kind on the premises. I agree that violation of any of the Bearded Axe rules is grounds for immediate expulsion with no refunds.

By hitting accept, you are consenting to the use of your electronic signature in lieu of an original signature on paper. You have the right to request that you sign a paper copy instead which is available at our location. By hitting accept, you are waiving that right. After consent, you may, upon written request to us, obtain a paper copy of an electronic record. No fee will be charged for such copy and no special hardware or software is required to view it. Your agreement to use an electronic signature with us for any documents will continue until such time as you notify us in writing that you no longer wish to use an electronic signature.
